Intended Use/Indications for Use for selected devices provided in the kit:

Occluder™ Occlusion Balloon Catheter

The Occlusion Balloon Catheters are indicated for use for temporary ureteral occlusion and applications including, renal opacification, dislodgment of calculi and preventative calculi migration.

Any use for procedures other than those indicated in instructions is not recommended.

Percutaneous Access Needle

The Percutaneous Access Needle is intended to facilitate access into the renal pelvis, and to advance guidewires into the collecting system in an antegrade manner.

NephroMax™ High Pressure Nephrostomy Balloon Catheter:

The NephroMax Balloon Catheters are recommended for dilatation of the nephrostomy tract.

Re-Entry™ Malecot Nephrostomy Catheter:

The Malecot Nephrostomy Catheter Set is intended to establish percutaneous nephrostomy drainage and is indicated for the following:

- Diagnostic Indications:
 - Antegrade pyelography
 - Pressure/perfusion study (Whitaker test)
- Therapeutic Indications:
 - Nephrostomy catheter drainage
 - Perfusion chemolysis of renal stones
 - Percutaneous nephrolithotomy
 - Percutaneous resection and coagulation of urothelial tumors
