

#### **DEVICE DESCRIPTION**

The Blox Endoscopic Bite Block with Elastic Cloth Strap consists of a pliable polymer block and an elastic cloth strap. The bite block is positioned in the mouth to protect the patient's teeth and gums, as well as the endoscope equipment, from any damage. When present, the dental retention rim helps keep the device in place. The large upper flange helps prevent the bite block from resting against the patient's gums. Large lateral openings allow the user to position and guide the scope.






Figure 1. Blox Endoscopic Bite Block with Elastic Cloth Strap

### INTENDED USE/INDICATIONS FOR USE

The Blox Endoscopic Bite Block with Elastic Cloth Strap is intended to provide safe passage through the patient's mouth during upper endoscopic procedures thus protecting the patient's teeth and gums as well as protecting endoscopic equipment.

### CONTRAINDICATIONS

There are no known contraindications.

#### WARNING

Do not use if there is any apparent shipping or handling damage.

#### PRECAUTION

 Care should be exercised to avoid placing fingers between the bite block and the patient's teeth.

#### ADVERSE EVENTS

None known

#### HOW SUPPLIED

The device is supplied non-sterile and intended for single use only. The packaging and device should be inspected prior to use.

Do not use if package is opened or damaged.

Do not use if labeling is incomplete or illegible

#### **Handling and Storage**


Store in a cool, dry, dark place.

#### **OPERATIONAL INSTRUCTIONS**

- Remove the bite block from the package and inspect for any damage or irregularities. Do not use if damage or irregularities are present.
- Remove the elastic strap from the center hole of the bite block.
- Advance the bite block into the patient's mouth.
- Ensure that the slit on one end of the elastic strap is secured over the
  cleat on the side of the bite block. Secure the bite block into the patient's
  mouth by advancing the other end of the elastic strap around the back of
  the head and threading the appropriate slit in the elastic strap over the
  cleat located on the other side of the bite block.
- To make an adjustment to the position of the bite block, access the bite block through its lateral openings taking care to avoid placing fingers between the patient's teeth and the bite block.


